#### VIII. LIBRARIAN'S REPORT (Attachment #4)

**Library Director Bartenfelder** – Attended GAP Meeting last week. North Avenue corridor is bustling, new Burger King/Popeye's and Freddy's Frozen Custard are under construction. Village has submitted a grant approval for improvements at Camera Park. Working with Keith Knautz to integrate southside of library, including butterfly garden with Camera Park. Township Assessor sent out over 40,000 notices, quad year, values have increased. Attended Census Complete Count Committee meeting. RAILS applying for a grant for Chicago collar counties up to \$20,000,000 to redistribute to libraries to who meet requirements to use for census marketing, outreach and staffing time. Looking into bond refinance to lower rates. Public Services Report - summer reading had over 1000 participants. Dave Jansen completed ICIRR training, legal training prerequisite to assist with immigration legal forms. Over 50 people in attendance at Spelling Bee program, looking at making it a biannual event. Back to School Outreach is in full swing.

**Circulation Services Manager Hebert** – Sign-ups at back to school nights has led to about 100 new library cards being mailed out. 130 new E-marketing cards have been mailed out, gives new residents 90-day e-library access and hopefully leads to new residents coming in and trading in for a new library card.

**Assistant Director Perry** – Wooden fences have been installed, one on the east side by the preschool outdoor area and the other by butterfly garden, they enclose HVAC units. New meeting room chairs are in. New computers have been purchased for teen room, more computers in budget for this year.
