## AN ORDINANCE PROVIDING FOR THE LEVYING AND ASSESSMENT OF TAXES BY THE GLENSIDE PUBLIC LIBRARY DISTRICT, DUPAGE COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2013, AND ENDING JUNE 30, 2014

III. The property taxes extended or abated for debt service and public building commission leases for 2012 were \$361,415.00.

The estimated property taxes to be levied for debt service and building commission leases for 2013 are \$363,715.00. This represents a 0.64% increase over the previous year.

IV. The total property taxes extended or abated for 2012 were \$3,626,776.82.

The estimated total property taxes to be levied for 2013 are \$4,219,296.00. This represents a 16.34% increase over the previous year.
