

**AN ORDINANCE AUTHORIZING LEVY OF AN
ADDITIONAL TAX FOR THE MAINTENANCE, REPAIRS AND
ALTERATIONS OF THE LIBRARY BUILDING AND EQUIPMENT**

adopted by the Board of Library Trustees of the Glenside Public Library District at a regular meeting of said Board of Library Trustees, at which a quorum was present, held pursuant to the Illinois Open Meetings Act on the 16th day of October, 2014.

ORDINANCE NO. O-V-14

**AN ORDINANCE AUTHORIZING LEVY OF AN
ADDITIONAL TAX FOR THE MAINTENANCE, REPAIRS AND
ALTERATIONS OF THE LIBRARY BUILDING AND EQUIPMENT**

WHEREAS, Section 35-5 of the Public Library District Act of 1991 (75 ILCS 16/35-5) authorizes the levy of an additional tax of .02% of the value of all the taxable property in the District, as equalized or assessed by the Department of Revenue, for the maintenance, repairs and alterations of the Library building and equipment.

NOW, THEREFORE, Be It Ordained by the Board of Library Trustees of the GLENSIDE PUBLIC LIBRARY DISTRICT, DuPage County, Illinois, that it hereby determines to levy an additional tax of .02% of the value of all the taxable property in the District, as equalized or assessed by the Department of Revenue for the maintenance, repairs and alterations of the Library building and equipment.

BE IT FURTHER ORDAINED that within fifteen (15) days after the adoption of this Ordinance, the Secretary shall publish it at least once in one or more newspapers published in the District, or, if no newspaper is published therein, then in one or more newspapers with a general circulation within the District.

BE IT FURTHER ORDAINED that if no petition is filed with the Board of Library Trustees by November 21, 2014, thirty (30) days after the aforesaid publication, the District shall then proceed with the levy of said additional tax. However, if within the thirty (30) day period a petition is filed with the Board of Library Trustees, signed by electors of the District equal in number to 1,731 or more of the electors (being 10% or more of the registered voters of the Library District) in the Library District, asking that the question of levying such a .02% tax be

submitted to the electors of the District, the question shall be submitted at the February 24, 2015 Consolidated Primary Election or within seven (7) days of receipt of said Petition, the Board of Library Trustees may void the Ordinance and the .02% tax shall not be imposed. If the question is placed on the ballot and a majority of votes cast upon the question are in favor thereof, the Board of Library Trustees may levy the additional tax. The Secretary of the District shall provide a petition form to any individual requesting one.
