VIII. **LIBRARIAN'S REPORT** (Attachment #4)

Library Director Bartenfelder – Had false fire alarm last week. Evacuation went smoothly. Had sensors replaced in HVAC and Fox Valley Fire replaced fire sensor in duct. The book sorter is back in commission, bad roller was repaired. Reorganizing plants in front of library. Immigrant Solidarity of DuPage/Sierra Club volunteers installed a butterfly garden. Will connect flagstone

path to garden. Auditor finished fieldwork and data collection at library in three days. Should be getting a draft audit in a couple of weeks for approval. Cooperation with School Resource Officer Cahill is beneficial for afterschool incidents. Receipt software will now print out amount you saved by checking out items instead of buying and will advertise programming.

Community Outreach Specialist Sovanski – Youth Commission met. To be proactive they are participating in 20 for 20 to provide Sports Hub passes to students in the community. Jill and I have met with three book sellers this month. Kiwanis participated in Community Garage Sale and Vince was installed as new president. Peanut Days is in progress with Character Counts. Family Health and Safety is on Wednesday, October 3rd, library is a sponsor and Friends of the Library will participate.

Public Services Manager Martorano – Immigrant Solidarity of DuPage will have a Day of the Dead event at the library the first weekend of November, Friday and Saturday after hours. How-to-Fest received positive feedback. Public Services Staff attended homelessness training. Ann McDonald retired, but is still staying on as a sub. New staff member Lydia Stucki.
