# GLENSIDE PUBLIC LIBRARY DISTRICT BOARD OF TRUSTEES MEETING MINUTES June 20, 2019

A. Trustee Milnes moved and it was seconded by Trustee Baldwin that the GPLD Board of Trustees accepts the Bills Approval Report (file with the Treasurer's Report) for June 20, 2019 in the amount of \$158,729.43. Ayes – all present. Nays – none. Motion carried.

## VIII. LIBRARIAN'S REPORT (Attachment #4)

**Library Director Bartenfelder** – Postponed signage project, will do in house next year.

Plantings outside are doing well. Dealing with the Budget & Appropriations and wrapping up the financial year. In touch with the auditor, sent over approximately 70 files, they do most of their work remotely. Vince Sovanski's last board meeting, retiring on July 11th. Thanked him for all his hard work on non-profit and village committees that have brought the community together.

**Community Outreach Specialist Sovanski** – Has wrapped up work on the committees he has been a part of and various library employees will be picking up the work. Volunteered with Kiwanis at the Glendale Heights Charity Golf Outing, donation of \$15,00 to Make-a-Wish, \$5,000 to Chamber of Commerce for scholarships, and \$5,000 to FOP. Will continue to work part time after July 11th.

**Assistant Director Perry** – Rebranding for My Media Mall to Digital Library of Illinois due to shift from being managed by Libraries First to Intergovernmental agreement.

**Public Services Manager Martorano** – PC Clerk has resigned due to end of school year, Alex Finnegan will be the replacement starting next week. Mercedes Martinez is the new part time Public Services Librarian. Both new employees speak Spanish. Summer Reading had 1,262 sign-ups in the first 2 1/2 weeks. Outreach is taking place at daycares, NEDSRA, summer camps and schools. D15 is providing mobile feeding events twice a month with van received through a grant. Two librarians are attending events to provide story time, crafts and free books. 30 attendees for first event earlier today.

- B. Trustee Barreras moved and it was seconded by Trustee Khokar that the GPLD Board of Trustees authorize purchase of public meeting room chairs (100) and dollys (10) from Library Furniture International (LFI) in the amount of \$23,190 (Attachment #6). Ayes all present. Nays none. Motion carried.
- C. Trustee Baldwin moved and it was seconded by Trustee Evans that the GPLD Board of Trustees approve Personnel Committee Recommendation of 3% increase of Library Director Salary. Ayes all present. Nays none. Motion carried.
