**Library Director Bartenfelder** – Attended GAP meeting. Hospital is encouraging people to return for regular procedures. Village has canceled Oktoberfest, Car Show and Harvest Fest and is investigating social distanced Halloween events. Police Department is reporting uptick in mental health agitated violence and domestic

issues. Requesting increase from the mental health grant to get 10 more hours of social service time. Three vacant positions at that library that we are not actively trying to fill due limited staffing points in the library. Entered next phase of opening library, remote learning support. Eliminated one-hour soft recommendation and patrons can now stay as long as they want. Set up as many places as possible for students to remote learn in library. District 16 is interested in virtual outreach. Extended hours on Friday starts on August 28<sup>th</sup>. New Happy with public response to safety guidelines. No cases of COVID-19 among staff.

**Assistant Library Director Peery** – Working closely with SWAN toward December go live date for new integrated library system. Next step is testing to make sure systems are working as anticipated. August 31<sup>st</sup> will be start of virtual training.
