GLENSIDE PUBLIC LIBRARY DISTRICT BOARD OF TRUSTEES MEETING MINUTES May 20, 2021

I. **CALL TO ORDER**

The regular board meeting of the GPLD Board of Trustees was called to order at 7:00 p.m. by Board President Sam Lucente at the Glenside Public Library.

X. LIBRARIAN'S REPORT (Attachment #4)

Director Bartenfelder - Study room construction is on schedule to be completed by July 1st. Circulation Manager Jane Hebert is attending her last board meeting after starting at Glenside Public Library 9 years ago. She is retiring at the end of the month. 40 resumes were received for her open position and 7 interviews took place. Pam Kamin will be training parttime and will be starting fulltime on June 16th. She comes to us from Batavia Library where she was the Assistant Circulation Manager. The governor changed mask mandate and fully vaccinated no longer need to wear a mask in the library. Staff will still be required to wear a mask. Signs with new policy have been ordered but are delayed. Village has not gotten back on what their new policy will be.

Public Services Manager Martorano – Staff room finished along with spring cleaning to get everything organized. Summer Reading preregistration has started on Beanstack. It will run from June 1st-July 31st. Planning summer events with Glendale Heights Police Department for Movie with a Cop. Library has purchased movie licenses. Material budgets end of year spending has finished.

Assistant Director Peery – Librarians workroom has new built-in desks. Counter desk was demolished and data and power connections were moved. Parking lot had normal wear over the winter and all cracks have been sealed. Lights on Youth Services displays have been installed. Public computers for searching catalog are being replaced.

Circulation Manager Hebert – Circulation department employees completed two SWAN trainings last month. Getting everything ready and going over items for Anees since there will be a short gap between Jane's last day and the first fulltime day for Pam.
